Further to our letter No. DTE/DJ-GIFT EDUCATION SCHEME /2021-22/2641 dated 22/11/2022, regarding the above subject, following clarifications are provided:

- 1. All newly admitted students in 2022-23 need to pay the fees as notified in the Degree Prospectus-2022-23.
- 2. However, students admitted in 2022-23, who are eligible and wish to avail DJ-GIFT Education Scheme viz. students who are eligible to avail the Scheme and whose annual Family income from all sources is below Rs.5 lakhs per annum need to provide Income Certificate for 2021-22, issued by Chief Officer of Municipality in case of Municipal areas or Panchayat in case of Village areas, stating that their annual family income from all sources does not exceed Rs.5 lakhs p.a.

Such students admitted in 2022-23, availing DJ-GIFT Education Scheme shall pay base fee of Rs.40,000/- per Semester (i.e. Rs.80,000/- p.a. in 2022-23) and other applicable fees. Institution shall collect the Income Certificate from such students.

3. Balance fee payable (as applicable) by students admitted in 2022-23, shall be collected by the institution and deposited into its own Fee Account, and NOT through the fee collection Account maintained by Directorate of Technical Education in HDFC Bank, Porvorim.

Thus, every admitted student in 2022-23 needs to be informed regarding the above, and make payment of the applicable fees to the institution.
