“BURSARY SCHEME FOR THE ACADEMIC YEAR 2023-24 & 2024-25”

The Goa Education Development Corporation is pleased to announce the “**Sant Sohirobanath Ambiyednyanvrudhi Shishyavrutti**” (Bursary Scheme) for the academic year **2023-24 and 2024-25**. The Goa Education Development Corporation (GEDC) has been implementing the “Sant Sohirobanath Ambiyednyanvrudhi Shishyavrutti” (Bursary Scheme) since 2014 onwards, every year around 600 Goan students benefit under the scheme. Upto Rs. 40,000/- is disbursed to needy students whose family income is below Rs. 5.00 Lakhs and studying in educational institutions located in the State of Goa. The students pursuing diploma courses after S.S.C., Graduation courses after H.S.S.C and P.G. courses after Graduation can apply under the scheme provided they fulfill the eligibility criteria listed under the scheme.

The GEDC has rolled out the Bursary Scheme for the Academic years 2023-24 and 2024-25. The scheme will remain open from 1st Feb 2025 to till 17th March 2025. The interested students are requested to avail the benefit of the said scheme. The last date for submission of the form to the GEDC office along with the requisite documents is 17/03/2025 no late forms will be entertained.


